OUTCOMES OF COP27 IN SHARM EL-SHEIKH

- A historical result on loss and damage with a decision to create new finance mechanisms.
- From a Danish perspective a disappointing result regarding mitigation with no substantial progress.
- Establishment of new work programs on Just Transition and Art. 2.1c on making global finance consistent with the Paris Agreement.



COP28 IN EXPO CITY DUBAI

- The next COP will take place in the United Arab Emirates (UAE)
- Focus on keeping 1.5 degrees alive.
- Big decisions to be made in Dubai:
 - Global Stocktake
 - Global Goal on Adaptation
 - New finance mechanisms for loss and damage
 - Results on Just Transition and 2.1c work programs

EXPECTATIONS FOR THE NEGOTIATIONS AT COP28

- COP28 is regarded as the most important COP since the Paris Agreement. IPCC warns that the climate crisis is getting out of control.
- Expectation that the global stocktake (GST) will play a central role at COP28.
- The outcome from GST shall "inform" the new NDCs (post 2030).
- EU priorities:
 - Acknowledge gaps and successes.
 - Focus on implementation and sector approach.
 - Increased ambition and action (also via NDCs).
 - Stronger involvement of NPS.



EXPECTED FOCUS FOR THE ACTION AGENDA AT COP28

- Still early in the preparations for COP28 and the UAE has not officially announced the ambition and direction for the action agenda.
- Thematic days are expected.
- We expect that side-events will play a central role in the two weeks of COP.

- COP28 is taking place from November 30 to December 12 with rest day on December 7.

High level segment from December 1-2

- UAE describes COP28 as a “COP of action”, with a goal to raise ambitions across adaptation, mitigation, loss and damage and financing.
- UAEs **ambitions** for COP28 implies:
 - Accelerate emissions reductions to keep 1.5 alive.
 - Deliver on the Global Goal on Adaptation through an upscaling of public and private finance.
 - Operationalize the fund for loss and damage.
 - Enable public and private climate finance.
 - Innovate the COP-process.

- The fund aims to provide financial assistance to nations most vulnerable and impacted by the effects of climate change.

Private sector action

Public-private partnerships for climate action

- With its 13 climate partnerships, Denmark is leading by example and shows concrete climate action.
- There is high interest globally in learning from this model and we want to spread knowledge about it on our platform.

Global climate footprint

- Denmark's emissions amount to approx. 0,1% of the world's total emissions.
- A consumption-based footprint is looking both inwardly, in terms of the climate footprint of our consumption, but also beyond our own borders on how exporting green solutions affects the global climate.
- It also considers reductions of scope 3 emissions

Driving mitigation with Danish solutions

- The Danish pavilion is a platform to showcase how Danish solutions can contribute to closing the gaps on the way towards reaching the Paris Agreement.

Private sector investments in adaptation

- Jointly, we can unveil the business case in adaptation and outline the needs of the private sector for investing in concrete projects.
- At the same time, we have Danish solutions that can support adaptation nationally and in other countries.

Private sector contribution to loss & damage

- Jointly, we can discuss how the private sector can contribute to new financing mechanisms for loss & damage and which solutions Danish companies can bring to the table.

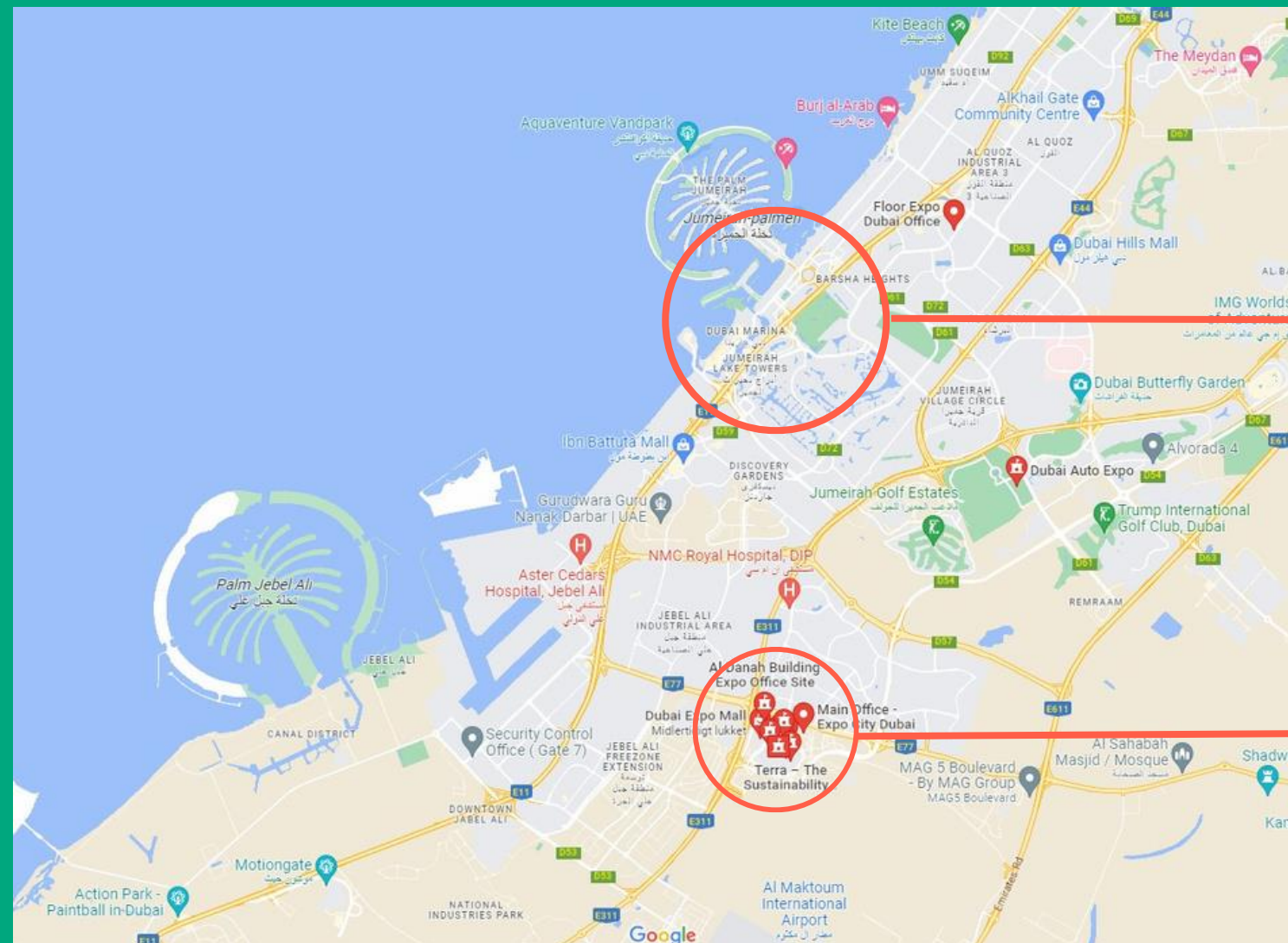

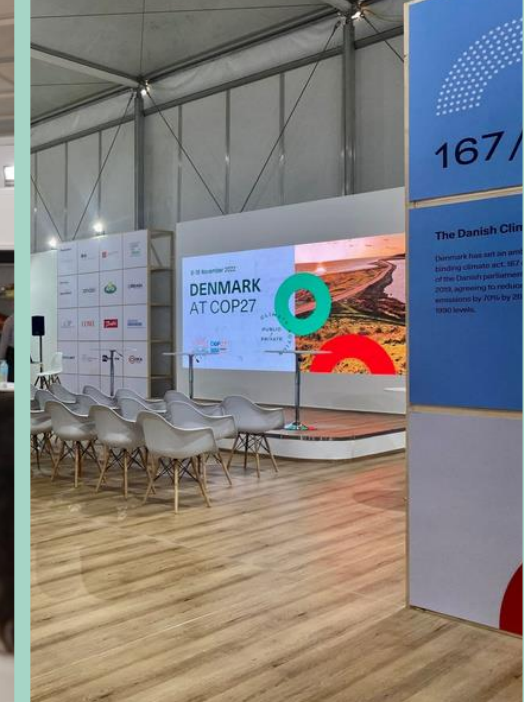

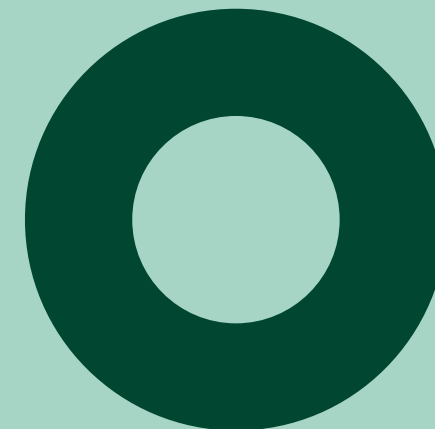
